

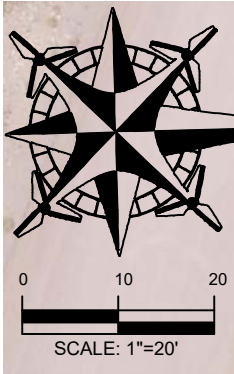
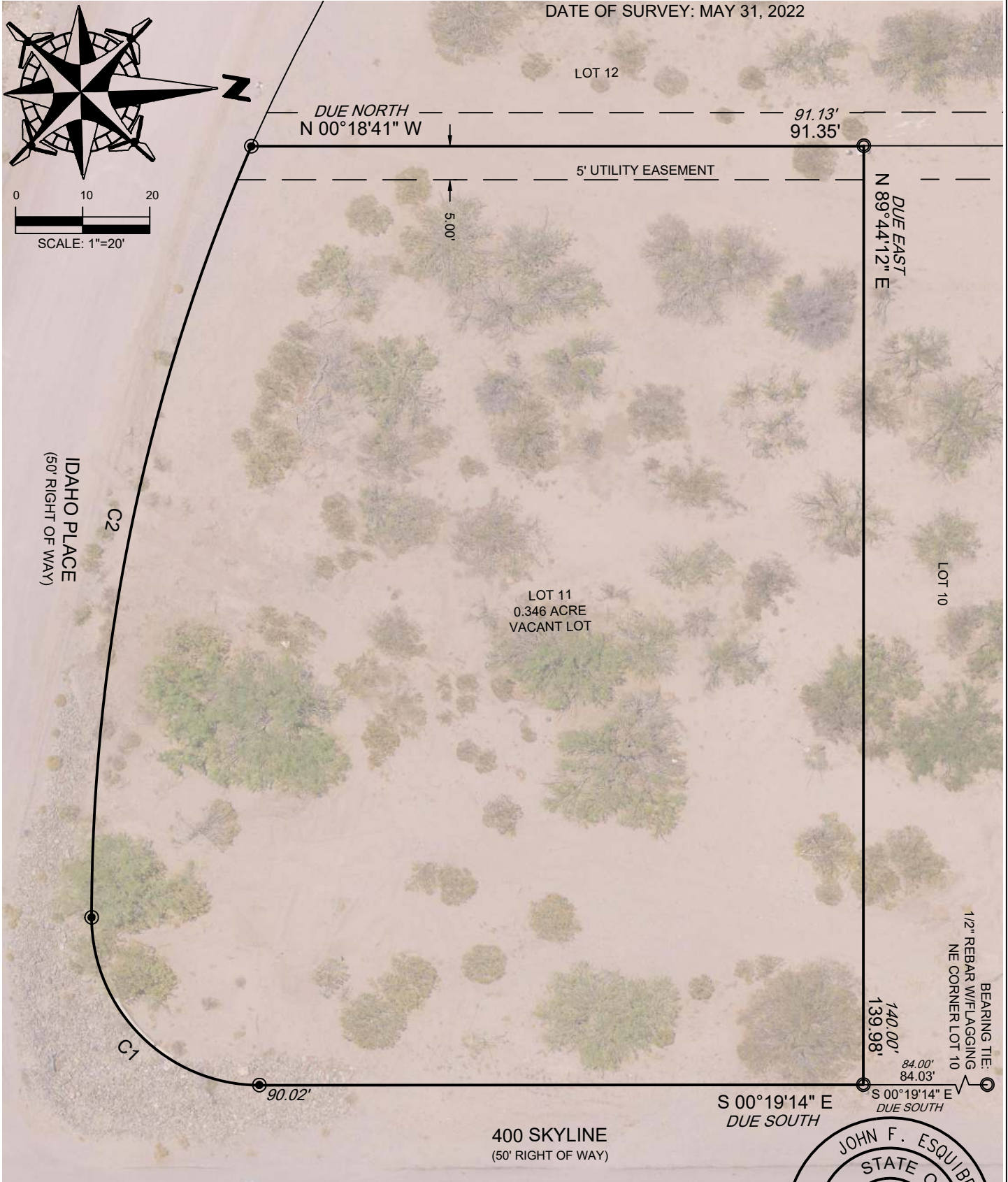

# BOUNDARY SURVEY PLAT

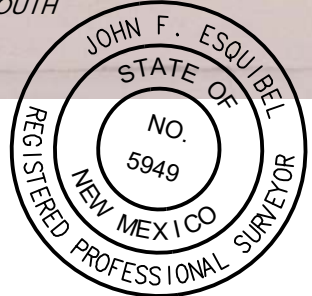
